## **RANGE RULE REMINDERS**

**THESE ARE SOME OF THE CURRENT RANGE RULES THAT A FEW MEMBERS SEEM TO FORGET**

### **General**

2. Eye and hearing protection shall be worn at all times while engaged in, or watching any shooting sport.
6. Each member shall display his or her current membership card while engaged in activities on the range.

### **Rifle / Pistol**

3. Individuals using the Rifle and Pistol Range or the designated Range Safety Officer will ensure that, before shooters move downrange, all firearms are in a safe condition with actions open or cylinders swung out, and are not handled while shooters are downrange.
5. While shooters are downrange, all other persons must be behind the red/yellow line and may not handle any firearm. Shooters may reload magazines behind the line, but must leave the firearm at the shooting position with the action open and muzzle pointed downrange or else in the vertical racks.
6. No Firearm shall be pointed at or discharged at anything but your own target(s). Firing at the 200 yard gongs is permitted.
  - 11a. No hard targets (steel) will be permitted within 200 yards of the firing line for center fire rifles.
  - 11b. No hard targets (steel) will be permitted within 50 yards of the firing line for muzzle-loading rifles/pistols or center fire pistols and .22 rifles/pistols.
  - 11d. No **targets of any type** will be allowed on the very top of a target holder or berm.

### **Safety Rules**

11. Anyone observed disregarding these range rules may have his or her membership revoked in accordance with Article IX of the Club Constitution By-Laws.
